





Kherson: urbanism and real estate

Report on Sociological Online Survey

Research background



Methodology: an online survey using an interactive structured questionnaire, a relevant link was sent to potential respondents from the database (online research panel of Kherson community). The sample is based on demographic indicators as of January 1, 2022. Given the indicators, the research margin of error does not exceed 5%, with a probability of 0.95. The sample includes Kherson residents both currently residing within the community, those who left Kherson after February 24, 2022 to other regions of Ukraine or abroad. Currently, there is no official data on Kherson residents' migration, so it is not possible to assess the given respondent sample representativity. However, there are reasons to believe that the ratio of respondents still residing within the community presented is greater than the de facto one, which may affect the research results.

Research objective: to assess public support for Kherson urban initiatives and real estate issues.

Sample scope: 402 respondents.

Field stage period: May 1 - 10, 2024.

Key Outputs



- Most Kherson respondents (71%) believe that Kherson recovery should be focused not on restoring the way it was before the war but on creating a new city. That said, the general vision of the main city restoration concept has not changed since October 2023.
- Most urban initiatives featuring the European city development were taken positively. The concept of urban space inclusion had the highest support - 97% of respondents believe that all Kherson public buildings should have special installations for people with reduced mobility. More than half also supported the idea of limiting large advertisements (big boards, etc.) use within the city (85%); transforming the historic part of the city into a conservation area to preserve its original appearance (84%); moving the port-elevator limits outside the and citu creating one long embankment from the seaport to the Voienka city district (75%); developing the "Kherson Resident Card" - an embossed plastic card serving both as a payment card and a cardholder's data carrier, supporting applications related to the provision and accounting of social assistance and other information functionality and services (71%); prioritizing the development of bicycle transport instead of the automobile one (68%); transforming part of Nezalezhnosti Avenue (Ushakova) into a pedestrian zone on weekends and holidays (58%); removing all outdoor structures (like kiosks, small shops, trade outlets) in the city (54%). However, initiatives related to reducing the number of vehicles in the city had less support. Only 45% supported the development of paid car parking in the city center, while 47% did not. Almost half of the respondents (48%) also supported the idea of adding one or two lanes to the roadway of Nezalezhnosti Avenue (Ushakova), which could hardly add to the image of a modern city.



- The damages inflicted on the Kherson residents by the war are growing. Mostly, it is about damaged housing and psychological deterioration. 46% of respondents stated having housing.
- The housing of **60%** of families who owned real estate before the war (which is 87% of respondents) was damaged during the war, and 5% completely destroyed. Still, **78%** of them are not into selling their property. There are by 11% more people wishing to sell their Kherson property among those who have left the city.
- 16% of all respondents claim that they are considering the issue of buying housing in Kherson. Moreover, there are 10% of such people among those who currently live in Kherson, while among those who have left 24%. 97% of respondents stated that they do not rent out their housing in Kherson, and 21% that their family members rent it in Kherson.
- The said real estate plans evidence both of intentions to return to Kherson and of the real situation in the city. **Kherson residents are not ready to get rid of their housing** and keep their opinion about the city's future, its image, and structure, that is, their planning includes the city.



General vision of Kherson restoration (N=402), %


Q.: Currently, there are a lot of discussions of Kherson restoration.

The dynamics of the general vision of Kherson restoration



Other answers:


- both / some things to be restored, and some newly created;
- some things to be changed, restored, but not as brand new ones;
- to change the damaged facilities but not to mess up the operational property;
- to restore whatever possible, and then create a new city;
- reconstruct the city as it was before the war and add new buildings; some symbolic sites should be restored in their original form;
- if possible, to restore and maintain historical monuments, develop modern infrastructure;
- to reconstruct the city, while preserving historical monuments;
- to restore historical buildings in their original form, to build new residential complexes instead of half ruined "Soviet era" ones:
- to restore architectural monuments, all temples and churches, to renovate the "survived" buildings, demolish all Khrushchev-era houses, and erect modern buildings, to make Kherson the pearl of the south;
- restore memorial sites, educational institutions, and create new recreation areas; restore old historical buildings and build a new city;
- develop infrastructure, leisure sites, reconstruct embankment, change the city central square; preserve cultural monuments, such as Kherson Fortress, Kherson Cathedrals, historical sites, liquidate pop-up markets, street trade, and restore the city as a City of Shipbuilders, as a port city, as a city of consumer goods and food industry.



- the house is on the left bank, so no information about it.




Dynamics of assessing the damage caused to the Kherson residents



Share of real estate owners among Kherson residents (N=402), %


Q.: Does your family own real estate in Kherson city community?






Status of the real estate owned by Kherson residents (N = 350, owners of real estate in Kherson), %

Q.: Do you and your family currently consider selling real estate in Kherson?






Plans to buy real estate in Kherson (N = 350, those owning no real estate in Kherson), %


Place of residence before February 24, 2022



Current place of residence


